After a trial last summer, Hope won a total victory on the merits of its claims, including a finding that the defendants had violated the unfair competition laws of five states, which was based on never-before-litigated provision of the U.S. Food, Drug, and Cosmetics Act.

The Fire Victim Trust will distribute the funds to the 70,000 victims who lost their homes and businesses in the fires. Recoveries obtained for the Fire Victim Trust will benefit of the fire victims; damages could exceed \$750 million.

The ordinance was enacted to protect public health and counter tobacco companies' efforts targeting Black communities with addictive menthol products and youth with flavored e-vaping products. Reynolds argued the County's ordinance was preempted by the 2009 Tobacco Control Act. Raygor successfully moved to dismiss the case.
