As Lawyers and Lawmakers Tackle AI, the 1990s Loom Large

Al innovation mirrors the early "Wild West" days of the internet – is regulation soon to come?

he 1990s seem like another world: boy band NSYNC was charting, flannel shirts were in and nascent internet businesses were flourishing under a light regulatory scheme.

Governments and citizenry alike viewed the future of this transformative technology almost entirely with promise. Then the dot. com bubble burst following intense growth in the online commerce of illicit products and bad ideas. Now, with artificial intelligence ushering in another boom, governments and citizenry are much more skeptical and have a desire to impose more regulatory restrictions on these companies.

"It was a forgiving regulatory environment," recalled Larry Sonsini, a corporate lawyer in Palo Alto, California, who is often called the "godfather of Silicon Valley."

"At the time, it didn't feel that way, because the kind of technologies that we had prior to that time, beginning with the semiconductors in the 70s and software and computers and personal computers in the 80s, there wasn't a lot of regulation there. The concern about unintended consequences wasn't prevalent with those kinds of technologies." Sonsini, who cofounded Wilson Sonsini Goodrich & Rosati PC and advised Google and Netscape in the 1990s, said that in hindsight, what was now clearly a light-touch approach – or in some cases a complete absence of regulation – was fundamental to the internet's success.

"I think it was necessary, because, as you look at the growth of the internet and the services in the 90s and 2000s, it gave us a great economic acceleration," he said.

Most experts agree that a light regulatory touch in internet businesses that was envisioned by the Clinton administration and then largely modeled by governments around the world was crucial to the creation of the online world that we live in today. But they also say that approach is unlikely to be adopted for the AI generation for reasons both political and economic.

"Nobody wants to be quoted as only an Al evangelist that turns a blind eye to potential problems, and a lot of that comes from having seen what happened in the internet, but we're in a very different zone in terms of being able to get things done as well," said Kenton J. King, another corporate lawyer in Palo Alto. King, a partner at Skadden, Arps, Slate, Meagher & Flom LLP and Affiliates, advised companies, including AltaVista and Yahoo during the late 1990s. Regulation of the internet "wasn't as much of a thing, to be honest," he said.

"The environment was so different. There was an environment where tech could do no wrong. Yes, there was a valuation bubble that got ahead of valuations, got ahead of where things were, but there was real optimism about what the internet could accomplish and what tech could accomplish," he said.

In line with that optimism, the Clinton administration took steps in the 1990s to support the rapid growth of the emerging internet. In 1996, it led efforts to overhaul the Telecommunications Act. While not specifically aimed at the internet, this update deregulated telecommunications and media ownership rules, opening the market to more companies and driving expansion of internet infrastructure. That same year, the administration passed the Communications Decency Act, which included one of the most influential provisions for the internet's growth - Section 230. Still central to internet law today, Section 230 protects online platforms from liability for content posted by their users.

Section 230 was "foundational in many ways to the growth of the internet by taking that liability away from platform providers on the internet and remains to this day an important piece of the architecture governing it," King said.

Contrast that approach to today and government efforts to grapple with artificial intelligence, where concerns about mitigating unintended consequences loom large.

Absent a handful of guiding principles issued by the White House, including a blueprint for an Al Bill of Rights issued in 2022, and federal regulatory agencies, efforts to govern the technology have been led by a patchwork of states. Sonsini said that this state-led approach was very different to what had occurred in the 1990s.

These efforts have primarily targeted specific concerns, such as potential bias in Al-driven hiring process as well as the creation of Al deepfakes and the use of name, image and likeness. Comprehensive attempts to regulate have been less successful, such as California's SB 1047, which would have made companies legally liable for harm caused by their platforms. That bill was vetoed by Gov. Gavin Newsom in September. Overseas, the European Union was the first to enact a comprehensive law governing Al. It categorizes Al systems by risk level, imposing stricter requirements on high-risk applications, such as those used in critical infrastructure or biometric identification, and holding high-risk applications liable for harm.

Taken collectively, these efforts tend to emphasize the potential risks of artificial intelligence. That's representative of what has been learned in the decades following the internet's mass adoption.

"Nobody at the inception [of the internet], or really until fairly recently, really understood a lot of the kind of societal harms that we needed to potentially be more thoughtful about, more proactive in terms of protecting our, you know, our young ones or others," said King's colleague, Skadden partner Ken D. Kumayama.

Kumayama, whose practice is focused on artificial intelligence, privacy and intellectual property, added that these societal harms, combined with dystopian images of artificial intelligence promulgated by science fiction meant many people had preconceived notions about AI.


Societal harms that are now being litigated were likely some "unintended consequences" of permissive regulation, Sonsini said.

"The downside was that it gave bad actors a microphone for their views. It created a pathway for disinformation, and it also, you know, captured a lot of young people with the iPhone, with the way that they related to some of the technology and depended on it for their own relations and their own education, and I think those are the things that started to worry us. Those were hard to foresee at the time," he said.

Realization of technology's potential for harm was evident in the way even the industry talked about itself. King noted that no AI presentation is complete without reference to the balancing of safety and benefits.

Both approaches to AI regulation – the United States' patchwork approach and the EU's broad regulation – had their advantages and disadvantages.

Kumayama gave privacy legislation as an example of the shortcomings involved with a jurisdiction by jurisdiction approach: "To date, there is no nationwide privacy law [in the U.S.] which makes it very difficult, frankly, for companies to comply with regulations, when you have patchwork of potentially 50 states that are engaged in regulation."

"Even Europeans will often say, you know, Europe has no innovation and lots of regulation, and the U.S. has no regulation, lots of innovation. And so, while that's a pithy statement, there, frankly, there's some truth to it," King said.

However, the risk of a lack of regulation in the United States is that "Europe ends up filling that space and becoming a default," he says.

"You had the unintended consequences of technology, but you also have the unintended consequences of regulation," Sonsini said. He added that he thinks "Europe is being aggressive too fast."

Eric Goldman, associate dean for research and professor at Santa Clara University School of Law, cautioned that the volume and extent of AI regulations, both those passed and proposed, represented a regulatory "tsunami" that had the potential to kill the generative AI industry in its nascent phase.

"There's technologies that never emerged because they got overregulated earlier," he said.

He gave the example of digital audio tapes, or DATs, a technology that faced significant pushback from the music recording industry upon their introduction in the 1980s.

"You've never heard of them because they were regulated so early. No one ever wanted to touch them, and so that technology just faded," he said. "Every single one of these new major innovations, we have the same question: when do we regulate? How much do we know about the technology at the time of regulating, and what will the regulation do to the evolution of the technology?

"We don't really know what that looks like, because we're thinking about it with our very limited perspectives that will only be proven right

Mid-Sized Law Firms Demonstrate Increased Productivity

Clio's recently released Legal Trends for Mid-Sized Law Firms report highlights crucial areas impacting mid-sized law firms, defined as firms with 20 or more employees



t encompasses financial performance, the impact of legal technology and – new this year – includes perceptions of artificial intelligence in legal practice.

The 2024 Legal Trends for Mid-Sized Law Firms report reveals that the average lawyer in a mid-sized law firm is earning more than ever before but still has significant billing and collection hurdles. Lockup, a new cash flow metric introduced this year, underscores a collection issue among mid-size law firms that if left unsolved, could create liabilities for firms. Getting paid faster is a key theme in this year's report, with smaller law firms outpacing their mid-sized firm counterparts in the adoption of online payments. The report also covers AI trends throughout the legal sector, unpacking how mid-sized law firms differ in their approach from smaller firms, and in some cases, even their clients.

"With the advent of AI, we have entered a new era of technology education and adoption across the legal sector, and we know that firms who find a way to leverage the technology are going to have a competitive advantage," said Jack Newton, CEO and founder of Clio. "This report uncovers an essential overview of how mid-sized firms are keeping up with the pace of rapid innovation, something that becomes increasingly difficult with larger business infrastructures and staff. And let's be clear, AI is not the only piece of the puzzle – tech adoption, particularly in collections and payments, is still lagging in certain workflows among the mid-sized firm segment. I encourage legal professionals to leverage this rich data to see where the competitive advantages lie among firms who make their technology work harder for the overall health of the firm."

A substantial increase in billable work signals heightened productivity and financial success

Insights from the report highlight a remarkable shift in mid-sized law firms, with a massive increase in billable hours compared to 2016, indicating heightened productivity across the segment. Individual lawyers are now billing substantially more and collecting more revenue, underscoring the significant financial and operational success of mid-sized law firms in the evolving legal landscape.



- Compared to 2016, mid-sized law firms in 2024 have experienced tremendous growth in the number of billable hours captured by their employees, capturing nearly 60% more than they did in 2016.
- Mid-sized law firms have experienced tremendous growth in the number of billable hours captured by their employees – at nearly 60% more than in 2016.
- The average lawyer in a mid-sized law firm is also earning more for their firm than ever before, billing 140% more and collecting nearly 180% more than in 2016.

Mid-sized law firms lead in billing speed but lag behind smaller law firms in payment collection

Law firms should closely monitor the speed and consistency of payment collection to avoid revenue being held in lockup, which encompasses unbilled and uncollected revenue. Mid-sized law firms, on average, demonstrate a proactive approach to generating invoices but struggle with the collection process.

• Mid-sized law firms exhibit a median realization lockup of 36 days, with the top 25% achieving a median lockup of 20 days, highlighting variations in billing efficiency.

• The median collection lockup for midsized firms is 52 days, emphasizing the need for improvement in the timely collection of outstanding payments.

Lawyers in mid-sized and smaller firms have similar attitudes toward AI use in the legal profession – but smaller firms may have more to gain

Lawyers in mid-sized and smaller law firms are approaching the integration of AI cautiously. While there is recognition of AI's growing importance in legal practices, some legal professionals remain skeptical about its current level of advancement and reliability.

Frequency and Severity of Large Cyber Claims Continue to Climb

Cyber claims have continued their upward trend over the past year, driven in large part by a rise in data and privacy breach incidents

As Allianz Commercial has warned in its annual cyber risk outlook, the frequency of large cyber claims (more than \$1 million per claim) in the first six months of 2024 was up 14% while severity increased by 17%. This is according to the insurer's claims analysis, following just a 1% increase in severity during 2023. Data and privacy breach-related elements are present in two-thirds of these large losses. Overall, the total number of cyber claims in 2024 is expected to stabilize, following a 30% increase in frequency during 2023, which resulted in 700+ claims.

"The growing significance of data breach losses among cyber insurance claims is driven by a number of notable trends," explained Michael Daum, global head of cyber claims at Allianz Commercial. "A rise in ransomware attacks including data exfiltration is a consequence of changing attacker tactics and the growing interdependencies between organizations sharing ever more volumes of personal records. At the same time, the evolving regulatory and legal environment has brought an uptick in so-called 'non-attack' data privacy-related class action litigation, resulting from incidents such as wrongful collection and processing of personal data – the share of these claims has tripled in value in two years alone."

Legal & Compliance Leaders Want to Increase Their Impact on Company Strategy

Legal, compliance and privacy leaders list strengthening their personal impact on company strategy as their top priority, according to a survey by Gartner, Inc.

> mproving third-party risk management (TPRM) and ensuring compliance programs can keep pace with fast-moving regulatory requirements are the top three priorities for this year.

The 2024 survey of 179 legal, compliance and privacy leaders showed that developing guidance that enables the business to better balance risk and business benefit, designing or updating compliance training to make it more tailored to employee needs round out their top five priorities.

"Legal and compliance leaders have neither resources, expertise nor visibility into the business to manage the impacts of geopolitical tensions or new technologies such as generative AI, alone. They must prompt others in the business to do more to own these risks," said Stuart Strome, director of research in Gartner's legal, risk and compliance practice. "General counsels and chief compliance officers already needed to be lawyers, risk managers and strategists, but now they must be influencers, diplomats and sales representatives as well."

Expanding Legal and Compliance's Enterprise Impact

The rapid and widespread adoption of new technologies – both internally and by third parties – is putting a lot of strain on legal and compliance leaders' time and energy. There will be some risks the business can own and manage, but others require a level of expertise the business lacks.

"Legal and compliance leaders must prioritize their time, leadership style and management behaviors to maximize team performance and influence senior leadership to take these risks seriously," said Strome.

Strengthening TPRM Programs

Improving TPRM processes and/or technology was both the third most frequent choice among leaders' top five priorities and the most frequently selected top priority, which reflects enterprise stakeholder demands for increased accountability for TPRM activities and programming.

"Stakeholder attention on TPRM is being driven by more stringent environmental sustainability and human rights standards prompted by the Corporate Sustainability Reporting Directive (CSRD), SEC Regulation S-K, and Germany's Supply Chain Due Diligence Act," said Strome. "Legal and compliance leaders know they must improve existing TPRM programs or develop a TPRM program to manage the new associated risks."

Ensuring Compliance Program Strategy Keeps Pace with Regulatory Requirements

Legal and compliance leaders are faced with an increasingly volatile and complex regulatory and enforcement environment across jurisdictions.

"Many legal and compliance leaders are looking for strategies to implement a robust regulatory intelligence system to help stay on top of rapidly shifting regulatory requirements," said Strome.

Securities Class Action Filing Activity on the Rise

Tracking of artificial intelligence-related filings began while the number of cryptocurrency-related filings declined

> he number of securities class action filings increased in the first half of 2024 relative to the second half of 2023, according to a recent report by Cornerstone Research and the Stanford Law School Securities Class Action Clearinghouse.

The report, *Securities Class Action Filings – 2024 Midyear Assessment*, found that plaintiffs filed 112

securities class actions in federal and state courts in the first half of 2024, an increase from the 103 class actions filed in the second half of 2023. The number of core filings – those without merger and acquisition (M&A) allegations – in 2024 H1 (110) was above the number of core filings in 2023 H2 (101) and the historical semiannual average (96). Tracking of the Artificial Intelligence (AI) trend category began; there were six such filings in the first half of 2024. The number of filings in all other trend categories – including cryptocurrency – is on pace to decline in 2024, except for COVID-19related filings, which are on pace to increase.

The potential for real liability resulting from Artificial Intelligence is among the more interesting developments of the past six months.

"While we've seen AI-related filings in recent years, the first half of 2024 marks the beginning of tracking these filings as a trend category. The growing prominence of AI in the business models of many companies may lead to more filings in the future," said Alexander "Sasha" Aganin, the report's coauthor and Cornerstone Research's senior vice president. "Meanwhile, SPAC-related filings are on pace to decline steeply relative



to recent years, and cryptocurrency-related filings, which have been hot for the past several years, experienced a sharp decline."

The number of filings with federal Section 11 and state claims under the Securities Act of 1933 remained low in the first half of 2024. The annualized number of these filings, 22, is in line with the number of filings, 21, in 2023. There were two federal M&A filings, on pace to be the lowest annual total since tracking of federal M&A filings began in 2009.

The Maximum Dollar Loss (MDL) Index decreased 9% to \$908 billion in the first half of 2024, a continuing decline from the inflation-adjusted record high set in the first half of 2023 but remaining 51% above the historical semiannual average. The Disclosure Dollar Loss (DDL) Index increased to \$185 billion in 2024 H1, a 9% increase from 2023 H2 and the sixth consecutive semiannual period with DDL at or above the historical semiannual average of \$119 billion.

"The potential for real liability resulting from artificial intelligence is among the more interesting developments of the past six months," according to former SEC commissioner Joseph Grundfest, now professor emeritus at Stanford Law School. "But more immediately, keep an eye on the upcoming Supreme Court term. Important decisions will be issued in the NVIDIA litigation regarding pleading requirements for securities fraud claims and in the Facebook/Cambridge Analytica litigation involving risk factor disclosure."

Additional Key Trends

- The likelihood of a core filing against a U.S. exchange-listed company is on pace to increase to an annualized rate of 3.9%, surpassing the 2010–2023 average of 3.6% for core filings.
- In the first half of 2024, there were 10 mega DDL filings (those with a DDL of at least \$5 billion), twice the 1997–2023 semiannual average (5) and slightly above the number of mega DDL filings in 2023 H2 (8).
- The number of core federal filings in the Second and Ninth Circuits increased and comprised of 60% of the total number of core federal filings in 2024 H1. DDL

in the Ninth Circuit more than tripled relative to 2023 H2, while DDL in the Second Circuit decreased by 84%.

 Core federal filings against non-U.S. issuers as a percentage of total core federal filings in 2024 H1 declined by nearly a quarter relative to 2023, reaching a 15-year low.

To support growth, the firm provides training opportunities and career development for employees at all levels. Shortz noted that her legal assistant started as a receptionist. For attorneys, it means instituting a plan to ensure that associates begin to think like partners and understand how the business works. That process starts with new hires: In September, three attorneys joined the firm in Los Angeles fresh out of law school. They will develop legal skills through a full trial advocacy training program, but will also learn how to efficiently and effectively settle cases – many eventually settle, since trials can lead to higher risk and costs.

Growth Outlook

Although there was speculation that companies would leave Southern California post-COVID-19, and there have been some high-profile companies that have done just that, there are still a plethora of businesses that remain in Los Angeles that support the local economy and need legal support. In terms of the practice areas with high demand, she noted that employment is always a hot-button area and there can be significant litigation even when cases settle. Alternatively, high interest rates have softened the real estate and corporate work related to transactions, but that work has been picking up recently.

Moreover, upcoming global sporting events in Los Angeles will provide a boost to the hospitality industry. As a labor and employment attorney, Shortz sees firsthand how changing regulations impact the hospitality industry, which frequently rely on legal support for compliance and labor disputes.

"In terms of our local economy, hospitality is a big part of the lifeblood of this city and it's going to become more important with these events coming. We see it with the infrastructure too and the real estate practice area," she said.

Community Involvement

While Shortz is excited for upcoming events and excited to be involved through partnerships with organizations such as the Los Angeles Sports and Entertainment Commission, she and the firm are also looking at ways to support the local community through philanthropic endeavors.

Michelman & Robinson works closely with Angel City Sports and supports Ronald McDonald House, which will soon open a new location in Westwood close to the firm's office. "We have a robust pro-bono program at the firm and work with organizations that have a large presence or are based in Los Angeles," said Shortz. Angel City Sports is a Los Angeles-based nonprofit that provides adaptive sports opportunities for people with physical disabilities or visual impairments. It organizes about 250 clinics per year across 25 sports. Ronald McDonald House is building a large new facility in Westwood to serve families and children who are receiving treatment at UCLA Mattel Children's Hospital, or other westside medical facilities, and the firm plans to work with them on events and activities when it opens.

Ultimately for Shortz, growing and elevating her role at the firm shows no signs of slowing. "Culture is a big piece of our firm – it's one of the reasons that I've been here for so long." she said.

To view or share this content online, use this QR code. Competition for Technical / Skills Set to Intensify for Legal and Compliance Functions

> A growing technical skills gap is a top concern for legal and compliance leaders, according to a recent survey by Gartner, Inc.

A survey of 179 legal, compliance and privacy leaders, found that 65% of respondents noted a technical skills gap among their top five concerns in the next two years.

BUSINESS OF LAW

Gartner experts said that the rapid deployment of generative AI within the business and a host of new technical regulations, such as the Digital Markets Act and ePrivacy regulation, require combinations of technical and legal or compliance skills that are currently in very short supply.

"Typically seen as a barrier to innovation, legal and compliance functions will struggle to compete for this kind of talent, even within the company, against departments that offer better career advancement opportunities and can provide more enticing benefits and compensation packages," said Stuart Strome, director of research in Gartner's legal, risk & compliance practice.

"Heads of legal departments should start developing their long-term talent management strategy," Strome said. "Even lawyers right out of school won't be equipped with certain in-demand skills, so leaders must create opportunities in their departments for lawyers to learn these skills – either on the job or through partnership with educational institutions."

Legal departments are facing two main issues regarding this technical skills gap. First, lawyers may be resistant to incorporating new technology into their workflows, especially if it requires major changes to how they operate. So, as pressure grows for legal departments to increase productivity with new tools, legal ops leaders must make sure these tools work as promised and that lawyers have the right training to use them.

Second, both the EU AI Act and the Biden Administration's executive order on AI contain new requirements to minimize the risks of model bias and explainability.

"Legal leaders must be able to communicate these requirements to business partners and have a sufficient level of technical understanding to know whether their companies' efforts will achieve compliance," Strome said.

Gartner experts have outlined four main areas where scarce technical skills will impact legal and compliance teams.

Talent Management Strategy

There will be in-demand areas where legal and compliance simply will not be able to hire all the skills they need; legal leaders will need to make trade-offs and consider hires they typically would not (e.g. lower levels of experience).

"In the long term, legal departments must ensure they are attractive to candidates with in-demand skills," said Strome. "The competition for this talent is ramping up, and legal leaders will need to partner with HR to develop a talent recruitment strategy and an enticing employee value proposition."

Internal Skills Development

Some technical skills can be developed in-house through internal training programs, external courses or partnering with outside counsel. Instead of hiring for all skills, legal departments should upskill current staff to fill technical skills gaps where possible.

Internal Technical Partnerships

Other functions in the company – such as IT, information security and data and analytics – likely already have employees with the technical skills and expertise needed by legal departments.

"When legal and compliance is seen as a roadblock, other departments may be hesitant to share resources," said Strome. "To get access to the technical abilities they will need, legal leaders must cast off this perception and seek mutually beneficial opportunities to share technical skills and capacity."

Workload Allocation

With approximately half of legal work sent to external providers, legal departments should prioritize sending work to outside counsel that requires technical experience when it is too costly to develop in-house. This is particularly true in cases in which regulations require highly technical knowledge to correctly interpret and devise a response.



The steep adoption of AI has the potential to disrupt how lawyers operate the business side of their firms. Clio's analysis shows that up to 74% of hourly billable tasks – such as information gathering and data analysis – could be automated with AI. Law firms should consider moving away from hourly billing in favor of more flexible options like flat fees to preserve profitability while benefiting from the increased efficiencies AI brings to legal workflows. As AI reduces the time spent on billable work, law firms may see a decline in revenue if they continue to rely on hourly billing.

Key highlights from the report:

- Al could make law firms more effective in working with clients as a result, they may need to invest more in marketing to attract an increased client pipeline. The ability to handle more clients will require a stronger emphasis on marketing strategies to sustain the workload and grow the business.
- The number of legal professionals using AI has surged from 19% in 2023 to 79% this year, marking a significant shift in how law firms are integrating AI into their daily operations.

ason Weintraub has had a stellar in-house career not just at Jacuzzi Group, where he has worked for the past four years, but also at companies such as Taco Bell, Broadcom Corporation, Bosch Home Appliances and El Pollo Loco (at the latter two companies, he served as chief legal officer). At Jacuzzi, he has led the deal team for two significant completed acquisitions in the past two years. The acquisition of Baths for Less allowed Jacuzzi Group to enter the bath remodel business. This is now the company's fastest-growing segment, with revenue having increased by over 10 times since the closing date. The other acquisition was Vortex Leisure, the largest spa manufacturer and retailer in Australia/New Zealand, the third largest spa market in the world. These acquisitions allowed Jacuzzi Group to increase its global spa retail footprint by over 60%, while adding two global spa brands to its portfolio.

Weintraub also commenced litigation on multiple continents against a major spa business competitor to enforce Jacuzzi's intellectual property rights. He and his team obtained a complete victory less than six months after filing suit, including a worldwide commitment by the competitor not to sell the infringing product. He also successfully filed a declaratory judgment action against a significant bath business competitor who was threatening a patent infringement action. In that case, he obtained a favorable settlement less than three months after filing suit that cleared Jacuzzi's product for sale without restrictions or payment.

Weintraub has obtained \$5.3 million in insurance recoveries in 2023 alone. He has also reduced Jacuzzi Group's global insurance premiums by over 50% in the past two years, saving over \$9 million per year. Weintraub has also dramatically strengthened Jacuzzi's trademark/brand protection program for the globally famous Jacuzzi trademark. Results of that effort have included a 180% increase in enforcement activity; a 10 times increase in efficiency of infringement detections; a 95% enforcement success rate; and successful enforcement against four major global competitors without the need for litigation. In addition, Weintraub was promoted in 2023 to lead Jacuzzi's Regulatory, Employee Health & Safety (EHS) and ESG functions.





or wrong with hindsight." He cautioned that overregulation could also result in the capture of AI by governments "and weaponized for government purposes, most obviously in something like censorship."

Kumayama said that it appeared that U.S. leaders were at least cognizant of the need to balance innovation with public safety, citing Gov. Newsom's decision to veto SB 1047.

"I think that California is trying to strike that balance. But it's tough. They're trying to be a lot more open to innovation than the EU," he said.

Given the pivotal role Section 230 played in allowing companies to innovate, is there a role for a similar provision applicable to artificial intelligence companies?

"We need something like Section 230 that provides some liability breathing room for generative AI model makers," Goldman said. "If they are liable for the contents that they publish, that is an untenable situation. And as a result, government interventions are necessary to provide that breathing space." He added that this may not be the case if courts determine AI products are covered by First Amendment exemptions and noted that this relatively novel legal argument was only in the early stages of being litigated, citing a recent decision by a federal judge to California's AB 2839, which allows individuals to sue for damages over election deepfakes. *Kohls v. Bonta*, 2:24-cv-02527-JAM-CKD (E.D. Cal., filed Sept. 17, 2024).

"230 really opened the door for continued innovation and taking the risk because of the protections that 230 gave," Sonsini said. "I think that there may be the same kind of need, I'm not sure yet, and 230 is a roadmap that we can learn from ... it's on the table, but I think it's open."

"This is an area that, like so many other areas of the law, it would be logical and it would be reasonable to have some sort of an accommodation," Kumayama said.

However, he cautioned, "I don't think anybody really is seriously saying Section 230 just ought to automatically apply to AI. That's sort of a square peg and round hole."

Given the present lack of clarity, Sonsini said he's excited but sober about the prospects of AI.

"It's a complicated question, but I'll tell you, the energy is there. The investment drive is there. The innovation is there," he said.

King and Kumayama both described themselves as "Al optimists."

"I think that it has tremendous potential to change the world in a positive way," King said.

"That level of potential impact, that does, I think, demand some level of regulation or significant level of regulation," he added.

"I do worry about how, in our current political system, we're able to achieve that in a sensible way."



'Non-attack' claims increase as privacy litigation ramps up

The rise in 'non-attack' data privacy claims is the consequence of developments in technology, the growing commercial value of personal data and a developing regulatory and legal landscape. For example, unlike the EU's General Data Protection Regulation (GDPR), privacy regulations in the U.S. are less prescriptive and open to interpretation, while plaintiff lawyers are hungry for potential sources of revenue. This is creating a grey area that is ripe for class action litigation, the report notes.

"We are seeing more data privacy breach claims in the U.S. where there is a growing trend for class-action litigation against large U.S. and international corporations related to privacy violations, such as around consent and data usage," said Daum. "The cost of some of these claims can be even larger than a ransomware incident, in the hundreds of millions of dollars."

Over the last year, in particular, data breaches have emerged as one of the fastest-growing areas of U.S. class-action litigation. Over 1,300 were filed across a wide range of data privacy regulations in 2023, more than double the number filed in 2022 and four times that filed in 2021, according to law firm Duane Morris.

Multiple class-action lawsuits have been launched against organizations across a wide range of industries, including healthcare, social media and gaming, for using Meta Pixel tracking tools to monitor consumer behavior, while entertainment streaming platforms have also been targeted, alleging that they may have violated privacy protection rights.

Large data breach events can also evolve into hyper litigation, with one event triggering a slew of class actions. More than 240 lawsuits related to the 2023 MOVEit data breach were consolidated into a single multidistrict litigation in October 2023. And with large numbers of claimants, there are incentives for parties on both sides to settle. The top 10 data breach class-action settlements last year totaled \$516 million, a significant increase over the \$350 million recorded in 2022. V
